On behalf of the APA Safety & Health Advisory Committee, I would like to congratulate all of the 2010 Safety and Health Award Winners. Please see the attached list of award winners. Winning mills will be presented with a plaque, recognizing their achievement, and will receive further recognition at APA's 2011 Annual Meeting.

The good news is the list of injury-free locations keeps on growing. The not so good news is the 2010 average WIR for our industry was 10.94, slightly over 2009's 10.64. The 2010 Average TIR was 2.44, which is a slight increase over 2009's 2.18. This is a demonstration of the fragile nature of safety. Your leadership is needed to reverse this upward trend. We owe it to our employees and it is also sound business to do so.

WIR (Weighted Incident Rate) is calculated using both the number and severity of recordable incidents. This is the third year that WIR is being used. Awards and reports also show TIR (Total Incident Rate) which has been used in previous years.

The APA Safety and Health Awards Program is the premier safety award program for the engineered wood industry in North America. It encourages and recognizes operational excellence with the goal of reducing injury and illness rates. While awards are limited to APA members, data is collected from both member and non-member mills. Please see the attached 2010 Industry Survey which shows the WIR and TIR for all participating mills.
